As per the recommendation of the Affiliation Committee meeting held on 29.11,2024 vide additional agenda, ratified by the Governing Body in the Meeting held on 26.12.2024 vide Agenda Item XVII and subsequent approval of the Controlling Authority of the Board, the following amendments has been made in Clause 2.3.5 of Affiliation Bye Laws 2018 which shall be applicable on applications of schools for affiliation under different categories for the session 2026-27 to be registered on SARAS 6.0 Portal.

Accordingly, following amendments in the Affiliation Bye Laws 2018 are hereby notified:-

**Existing Rule** 

Clause 2.3.5 :-

#### NO OBJECTION FROM THE RESPECTIVE STATE GOVERNMENT

The Schools mentioned under clauses 2.1.5, 2.1.6, 2.1.7 and 2.1.8, seeking affiliation with the Board shall submit formal prior "No Objection Certificate" to the effect that State Government has no objection to the affiliation of the School with CBSE. No objection Certificate once issued to any school will be considered at par even if it prescribes a specific period and / or level unless it is withdrawn

Amended Rule Clause 2.3.5:-

NO OBJECTION FROM THE RESPECTIVE STATE GOVERNMENT

The Schools mentioned under clauses 2.1.5, 2.1.6, 2.1.7 and 2.1.8, seeking affiliation with the Board are henceforth, will be permitted to apply on SARAS Panel for affiliation under various categories with or without NOC (No Objection Certificate) from the forthcoming sessions w.e.f. the session 2026-27.

In case, the school applies for affiliation without NOC, then the Board shall write to the concerned State Government to obtain their comments, if any, on the application of the school for affiliation with the Board. The department may furnish its comments regarding the said application, if any, at the link provided in the letter within 30 days of issue of the said letter. In case no comments are received within the said period of 30 days, a reminder letter will be sent to the concerned State Education Department to raise their objection, if any, within another 15 days, failing which, it shall be deemed that the State Government do not have any objection on the grant of affiliation to the school by the Board and the application of the school will be considered for grant of affiliation, if it otherwise, fulfils the conditions for grant of Affiliation as per the Affiliation Bye-Laws-2018 of the Board.





"Keeping in view the above said facts and circumstances, the present petition is disposed of with a direction to the Secretary, Department of School Education to consider and decide the representation dated 12.01.2023 (Annexure P-11), in accordance with law within a period of six weeks from the date of receipt of the certified copy of the present order. While taking a decision, the judgment of the coordinate Bench of this Court passed in CWP no.12389 of 2021 titled as "Ameliorating India, NGO vs. State of Punjab and others" decided on 02.11.2021 (Annexure P-8) be also taken into consideration."

2.0 The Federation of Private Schools and Association of Punjab filed a Civil Writ Petition no. 7238 of 2023 before the Hon'ble Punjab and Haryana High Court with the prayer to issue permanent recognition orders to members of the petitioner Federation in terms of the Right of Children to Free and Compulsory Education Act, 2009, and further, to issue recognition orders without incorporating the word 'provisional'.
