Membership -

I. Any men or women become the member of the school committee which pay the trust required membership fee to the trust, which decided by the Trust.

II. No person in employment of Trust becomes the member of the committee.

Termination of Membership -

- * If the person does such task which is against the institution.
- * If the person leaves India.
- * If the person dies.
- * If become absent sound mind.

Notice of General Meeting -

Ten days' notice shall be given to the members for general meeting of the trust for constitute the committee.

QUORUM OF THE MEETING -

1. The quorum of 50% shall be necessary for the meeting.
2. The quorum of 60% shall be necessary if change in by laws.

Election of the Managing Committee -

- I. The President shall be elected by the Trust.
- II. Powers are given to the president to form the committee.
- III. The school Principal will Act as Secretary of the Managing Committee.

Powers and duties of the committee -

- I. The committee shall be the executive body of the Trust.
- II. Appointment, suspensions, dismissal of the employees of the institution.
- III. To supervise in working of the institution.
- IV. To check the Account of the school.
- V. To celebrate the Annual function and various other religious function in the school.
- VI. To collect donation from the Public.
- VII. Take effective steps for the development of the institution.

POWERS OF THE PRESIDENT -

- I. The President shall be executive head of the institution.
- II. The President shall be executive Appointments, suspensions, dismissal of the employees of the institution and have all the powers to amend/modified the appointment letters if appointments do not match with the criteria of CBSE and State norms.
- III. He shall supervise the working of the institution and properties attached to them.
- IV. He shall make all efforts of correspondence on the behalf of the Trust.
- V. He will section leave and other than causal leave.
- VI. He shall submit the reports of the employee to the committee.
- VII. In the absence of president, the vice president or senior member preside over the meetings.

CASHIER-

The Secretary of the institution will act a cashier of the concerned institution. He or She will maintain the account.

OTHERS:

The school committee shall abide the rules of the govt. as well as of CBSE Board. Which are passed from time to time.

The school committee shall meet financial requirement of the school.

The school committee of the respective school will appoint any member or office bearer as correspondent of the respective school.
